

Call for Papers ASMI Annual Conference 2025

Justice and Trials in Contemporary Italy

28 & 29 November 2025 ILCS, Senate House, University of London

This conference will draw on interdisciplinary research into the history, politics, and cultural significance of Italian justice and trials in contemporary Italy. It will accept papers looking at individual trials as well as broader reflections around the justice system, actors in that system including lawyers, magistrates, judges, the accused, witnesses. Specific attention will be also paid to the social, political, and cultural impact of trials, and to the ways in which they have shaped and reflected Italian society (representations of that system in cinema, television, fiction, sport and comparisons between Italian justice and that seen in other nations). Trials have played a key role in Italian history – from the trials linked to the murder of Emanuele Notarbartolo in the 1890s, to those linked to political violence in the 1920s, to the trials of fascists in the 1940s, up to the Montesi case in the 1960s, the Red Brigades trials in the 1970s and 1980s and the Mafia maxi-trial in the 1980s, up to *Tangentopoli* and its numerous related trials in the 1990s. Different kinds of trials and investigations have also captured the popular imagination and dominated the media - from those linked to 'the monster of Florence', to the Cogne case, the Kercher murder in Perugia and numerous other cases of cronaca nera. Papers which investigate the methodologies of looking at trials and justice are particularly welcome, and/or the role of judicial archives. In so doing, the conference aims to foster a dialogue between historians, legal scholars, cultural critics, sociologists, journalists and practitioners.

Papers can be presented either in **English or Italian**.
